

“OFCA Fire Open Stage” Regulations

In order to ensure safety of the participants of the event, we hereby introduce these Regulations (hereinafter referred to as: the “**Regulations**”), worded as follows:

1. The **Regulations**, issued by the **Organizer**, i.e. by the “OFCA Foundation” based at ul. Sejmowa 1/5, 56-400 Oleśnica, KRS 559954, NIP 9112010907 (hereinafter referred to as: the “**Organizer**”), refer to “OFCA Fire Open Stage”, which will take place on 9-11 August 2019 in Oleśnica as a part of “Oleśnica's Festival of Circus and Art” (OFCA Festival). The purpose of the Regulations is to ensure the safety of participants of the Festival by defining the rules of behaviour of the persons present.
2. Participation in the OFCA Fire Open Stage is only allowed for adults with experience in fire shows (hereinafter referred to as the “**Participant**”) who don't have any medical contraindications against being in close proximity to fire and smoke. Minors are not allowed to participate in the OFCA Fire Open Stage.
3. To participate in the OFCA Fire Open Stage, one must meet all of the following conditions:
 - a) accept this Regulations by signing the Organizer's Declaration;
 - b) obtain and wear a wristband (given to the Participant when signing the Declaration). The wristband must be put on the participant's hand by the Organizer's staff member;
 - c) attend an organizational meeting.
4. The Organizer reserves the right to verify information given by the Participant and, in case of providing false information, to refuse his participation in the OFCA Fire Open Stage. The Organizer may also exclude the Participant from the OFCA Fire Open Stage when the Participant's behaviour poses a threat to his or other people's safety or disrupts the course of the OFCA Festival.
5. By declaring participation in the OFCA Fire Open Stage, the Participant bears full responsibility for his actions, including his own health, life and damages caused by him, both material and non-material, including to third parties during the organization and duration of the event.
6. The Organizer is not liable for any damage or damage to health caused by the Participant or that may result from his participation in the OFCA Fire Open Stage both toward the participant and third parties. This liability is charged entirely by the Participant.
7. By declaring participation in the OFCA Fire Open Stage, the Participant agrees to photographic and audio-visual documentation of his participation in the event, including his image and use of the obtained materials without time and territorial restrictions in a documentary, informational and promotional context of the OFCA Festival, OFCA Festival Sponsors and the City of Oleśnica.
8. By declaring participation in the OFCA Fire Open Stage, the Participant undertakes not to enter the stage area of the OFCA Fire Open Stage under the influence of alcohol, intoxicants, drugs marked as causing sight, hearing or balance disorders and other substances and products that make safe participation in the OFCA Festival impossible. He also undertakes to exercise extreme caution when he stays at the stage area of the event and to prevent from behaviour which may pose risk to other people's safety.
9. In case of disputes, the ultimate decision is made by the Organizer, whose vote is final.
