

“OFCA Fire Open Stage” Regulations

In order to ensure safety of participants of the event, we hereby introduce these Regulations (hereinafter referred to as: the “Regulations”), worded as follows:

1. The Regulations, issued by the Organiser, i.e. by the “OFCA Foundation” with its registered office at ul. Sejmowa 1/5, 56-400 Oleśnica, KRS 559954, NIP 9112010907 (hereinafter referred to as: the “Organiser”), refer to “OFCA Fire Open Stage”, which will take place on August 10th-12th 2018 in Oleśnica as a part of “Oleśnica's Festival of Circus and Art” (OFCA Festival).

The Regulations aim at ensuring safety of participants of the event by defining the rules of behaviour of the participants.

2. Participation in the OFCA Fire Open Stage is only possible in case of adults with experience in the fireshow (hereinafter referred to as the “Participant”), without medical contraindications against remaining in close proximity to fire and smoke. Minors may participate in the OFCA Fire Open Stage only after submission of a written consent from a legal guardian on the Organizer's template. Minors under the age of 16 are not allowed to participate in OFCA Fire Open Stage.

3. Preconditions of being the participant of the OFCA Fire Open Stage are as follows:

- a) acceptance of the Regulations by the Participant and signing the Organizer's declaration by them,
- b) receiving at the registration point at the Castle and wearing a wristband,
- c) attending an organizational meeting.

4. Only cumulative fulfilment of all conditions of point 3 gives the Participant opportunity to participate in the OFCA Fire Open Stage.

5. The Organizer reserves the right to verify information declared by the Participant and, in case of providing false information, to prevent the person from participating in the OFCA Fire Open Stage. Furthermore, the Organiser may exclude the Participant from the OFCA

Fire Open Stage if the Participant's behaviour posed a threat to their or other persons' safety or interfered with the course of the OFCA Festival.

6. Declaring their participation in the OFCA Fire Open Stage the participants declare that they are fully responsible for their actions, including their health, life and material and non-material damage caused by them to third parties during organization and in the course of the event.

7. The Organiser is not liable for any damage or health impairment that may result from participation in the Festival, incurred in connection with participation in the OFCA Fire Open Stage by both the participant and a third party. The participant bears full liability.

8. Declaring participation in the OFCA Fire Open Stage, the Participant agrees to photographic and audio-visual documentation of their participation in the event, including the image and use of the obtained materials, unlimited as to time and place in a documentary, informational and promotional context of the OFCA festival, the sponsors of the OFCA festival and the City of Oleśnica.

9. Declaring participation in the OFCA Fire Open Stage, the Participant undertakes not to enter the stage area of the Fire Open Stage under the influence of alcohol, intoxicants, drugs marked as causing sight, hearing or balance disorders and other substances and products that make safe participation in the OFCA festival impossible. They also undertake to exercise extreme caution when they stay at the stage area of the event and to prevent from behaviour which may pose risk to other people's safety.

10. In case of disputes, a decision is taken by the Organiser, who has a casting and final vote.
