I hereby declare that I, the undersigned,

have read and accepted the OFCA Slackline Regulations and the Regulations of Oleśnica's Festival of Circus and Art, taking place in Oleśnica on 10-12 August 2018 and I undertake to comply with all the provisions.

I hereby declare that I am aware that highline is a type of an extreme sport, which involves a high risk of unforeseeable phenomena, independent of the Organiser, which may constitute threat to life and health.

I hereby declare that I am fully responsible for my actions, including my health, life and material and non-material damage caused by me to third parties during organization and in the course of the OFCA Festival. In case of harm to my health as well as to health of third parties resulting from my actions, I bear full responsibility and take all the consequences of the situation. I hereby declare that I am aware of a risk associated with slackline (all types of slackline, including highline) i.e., in particular, bodily harm, injuries, long-term health detriment, loss of life, etc. I hereby declare that I agree to bear the above mentioned risk.

I hereby declare that there are no medical contraindications against my remaining at height or above the water.

I hereby declare that if the Organisers consider my behaviour to be threatening or interfering with the Festival, I will leave the venue at the Organiser's or the security service's request.

I hereby declare that I agree to the photographic, audio-visual documentation during my walks at the OFCA festival, including my image and the use of the obtained material, unlimited as to time and place, in documentary, information and promotional context of the OFCA Festival, OFCA Festival sponsors and the City of Oleśnica.

I hereby undertake not to enter buildings between which highline walks are organized and to rooms other than indicated and marked by the Organiser. I hereby undertake not to step on the line or slackline under the influence of alcohol, intoxicants, drugs marked as causing sight, hearing or balance disorders and other substances and products that make safe participation in the OFCA Slackline impossible. I hereby undertake to exercise extreme caution when I stay at the stage area of the OFCA Festival and to prevent from behaviour which may pose risk to other people's safety.

I hereby declare that when walking on a highline, I will not carry any items which could fall and pose risk to people and vehicles in the vicinity (e.g. a wallet, a phone, keys, etc.).

3. 6. Your personal data will not be processed in an automated manner including profiling.
7. The data controller has no intention to transfer your personal data to any third country or any international organization.
