2. The purpose of data collection is the Registration of Participants for OFCA Festival and OFCA Campsite.
3. You have right to access your personal data and correct it, erase it or limit its processing as well as right to objection, demand to stop processing and transferring the data, the right to withdraw your consent in any moment and the right to bring a complaint to the supervisory body (Prezes Urzędu Ochrony Danych Osobowych, ul. Stawki 2, 00-193 Warszawa).
4. Providing personal data is voluntary however failure to do so makes it impossible to register the Participant.
5. Your personal data will not be shared with the third party. The data recipients will be only institutions authorized by the law.
6. Your personal data will not be processed in an automated manner including profiling.
7. The data controller has no intention to transfer your personal data to any third country or any international organization.

9. If the participant is confirmed to be infected with the SARS-CoV-2 virus, the Organizer shall provide the relevant employees of the County Sanitary and Epidemiological Station with a list of people who stayed at the campsite and a list of people involved in its operation.
